NOW THIS INDENTURE WITNESS AS FOLLOWS :

1) Name of the Trust :

The Trust shall be named and called as "DURGA MOHAN MEMORIAL TRUST" (hereafter called the Trust).

2章 REGISTERED OFFICE:

The Registered office of the Trust at present shall be at Flat No.101, Konark Apartment, Cuttack Road, Bhubaneswar, P.S. - Laxmisagar, District - Khurda (Odisha) until and otherwise decided. The trust may have its own building and may hold office in any other place or places as may be decided from time to time by the Trustees as they may deem fit and proper at their discretion.

3) AIMS & OBJECTIVES :

The objects of the Trust, inter-alia, shall be :
