NOW THIS INDENTURE WITNESS AS FOLLOWS :

1) Name of the Trust :

2) REGISTERED OFFICE :

The trust may have its own building and may hold office in any other place or places as may be decided from time to time by the Trustees as they may deem fit and proper at their discretion.
